Two-Year Post Graduate Programme in Management (PGP) 2012-14 Batch

Admission Procedure for CAT 2011 Applicants

1. Eligibility conditions for CAT 2011 Applicants

The candidate must hold a Bachelor's Degree, with at least 50% marks or equivalent CGPA [45% in case of the candidates belonging to Scheduled Caste (SC), Scheduled Tribe (ST) and Differently Abled (DA) categories], awarded by any of the Universities incorporated by an Act of the central or state legislature in India or other educational institutions established by an Act of Parliament or declared to be deemed as a University under Section 3 of the UGC Act, 1956, or possess an equivalent qualification recognized by the Ministry of HRD, Government of India.

The percentage of marks obtained by the candidate in the Bachelor's Degree would be calculated based on the practice followed by the University/Institution from where the candidate has obtained the degree. In case the candidates are awarded grades/CGPA instead of marks, the conversion of grades/CGPA to percentage of marks would be based on the procedure certified by the University/ Institution from where they have obtained the Bachelor's Degree. In case the University/ Institution does not have any scheme for converting CGPA into equivalent marks, dividing the candidate's CGPA by the maximum possible CGPA and multiplying the result with 100 would establish the equivalence.

Candidates appearing for the final year of Bachelor's Degree/Equivalent qualification examination and those who have completed all the requirements for the award of Bachelor's Degree and are awaiting results can also apply.

Note 1: Aggregate marks of all semester/years of education will be considered for shortlisting as well as final admission.

2. Selection Process

Candidates seeking admission to the two-year PGP (2012-14 Batch) of IIM Indore have to appear in the Common Admission Test 2011 [CAT 2011] as described in the CAT 2011 advertisement, which was published in leading news papers on **August 7**, **2011**. CAT 2011 shall be conducted during **October 22 – November 18**, **2011**. Candidates can purchase the CAT 2011 vouchers from designated Axis Bank branch and register themselves on the www.catiim.in website during the period **August 17 - September 26**, **2011**. While registering for CAT 2011, candidates can apply to IIM Indore by selecting the option available in the online registration and there is no additional cost for the same. Please visit www.catiim.in website for further details.

Note 2: Any candidate who is interested in applying for IIM Indore need to exercise their option to apply while registering for CAT 2011. Only those candidates who will be applying for IIM Indore's PGP and satisfying the minimum eligibility conditions (given in Table 1) will be considered for admission process at IIM Indore.

2.1 Initial Screening: Those candidates who apply for two-year PGP at IIM Indore and satisfying the following sectional minimum percentile scores in CAT 2011 (given in table 1) will be considered for the subsequent shortlisting process.

Note 3: The above cut-offs are tentative and IIM Indore can modify, if required, at the time of shortlisting.

2.2 Shortlisting for WAT and PI: Candidates satisfying the criteria mentioned in step 1 (Table 1) will be considered for further shortlisting for Written Ability Test (WAT) and Personal Interview (PI). A merit list of candidates will be prepared based on their performance in CAT 2011, Academic performance, Professional diversity and other distinctions if any using the following composite score.

Composite Score (100%) = CAT 2011 Score (50%) + Academic Performance (45%) + Professional Diversity (5%).

Note 4: In case of CAT 2011 performance, suitable weightages for sectional percentile scores will be used while computing the composite score. Academic performance of 45% includes performance at Secondary/X Std/Equivalent, Higher Secondary/XII Std/Equivalent/ Bachelor's Degree. Across all categories (General, NC-OBC, SC, ST and PWD), candidates with professional diversity (like CA, ICWA, CS, Medicine/Dentistry and Law) will be given a maximum of 5 points depending on their performance while shortlisting for WAT and PI.

Note 5: The academic performance of the candidates will be standardized using normalisation scheme across Boards, Universities and Institutions as applicable.

Candidates shortlisted for WAT and PI will be intimated usually by the end of January 2012. Individual regret letters will not be sent to applicants who are not called for WAT and PI. IIM Indore conducts WAT and PI in Bangalore, Chennai, Delhi, Hyderabad, Indore, Kolkata, and Mumbai. However, IIM Indore reserves the right to change the centers at any time if the situation warrants.

2.3 Final Selection: A merit list of candidates who attend WAT and PI will be prepared based on the following criteria and admission offers will be made considering reservation norms.

Final Composite Score (FCS) = CAT 2011 (50%) + WAT (15%) + PI (35%)

3. Reservations

As per Government of India reservation norms, 15% and 7.5% of the total seats are reserved for scheduled caste (SC) and scheduled tribe (ST) candidates respectively meeting IIMI's admission requirements; 27% seats are reserved for other backward classes - non creamy layer (OBC-NC) candidates meeting IIMI's admission requirements. In addition, 3% seats are reserved for persons with disabilities (as per the provisions of Persons with Disabilities Act, 1995) meeting IIMI's admission requirements. The three categories of disabilities are: (a) low-vision/blindness, b) hearing impairment, and c) locomotor disability/cerebral palsy. **Applicants are advised to refer the details given in CAT 2011 notification.**
